Introduction

The Board of Governors are the key strategic decision makers in schools and therefore have a vital role to play in improving and sustaining school and pupil performance also ensuring that resources are used well to give every child the best possible education. The Board of Governors work in partnership with the principal, staff, parents, pupils and the local community to ensure that the pupils have every opportunity to develop their skills and talents to their full potential within a caring and stimulating learning environment.

The Department of Education has prioritised the role of Governors as being pivotal to the success of the policy '*Every School a Good School*' which has focused on school improvement and raising achievement. It is acknowledged that all Governors actively contribute relevant skills, experience and attributes to the role and in order to further enhance and empower Governors with additional knowledge and information, the Education Authority (EA) *Training and Support Programme for Members of Boards of Governors* has been specifically designed to help Governors fulfil their roles and statutory duties. The programme will help Governors focus on their strategic responsibilities and understand how accountability and transparency can improve the effectiveness of governance and raise the educational standards of all our pupils.

The '*Training and Support Programme for Members of Boards of Governors, November 2018 – June 2019*' is designed as a regional programme enabling access to any course at any of the venues across the country. This booklet contains detailed information on the range of courses being offered. It is recommended that the training programme be discussed at the next Board of Governors' meeting when Governors can opt for courses relevant to their expertise and their roles and responsibilities within the Board of Governors.

Governors should avail of the wide range of training opportunities offered. These training sessions are a great opportunity to hear current updates and learn about particular areas of responsibility. They are also a chance to meet fellow Governors from a variety of schools to share and learn from common experiences.

Target Audience:	The target audience for this training course is all governors in Primary and Post Primary.
Directorate:	Education Directorate
Aims:	This course will provide an overview of the Sustainable Schools' Policy Criteria and Indicators and how these can be used for school self-evaluation purposes.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To provide a better understanding of the Sustainable Schools' Policy Criteria and Indicators. • To provide a better understanding of the evidence required by governors to illustrate the Sustainable Schools' Policy Criteria and Indicators. • How these Indicators can be used by governors to self-evaluate the long term sustainability of their schools.

Course Title:	Child Protection and Safeguarding (Repeat)
Target Audience:	The target audience for this training course is chairpersons of Boards of Governors and the designated governor for child protection only. This course is a repeat of the course which took place in the 2014-15, 2015-16, 2016-17 and 2017-18 academic years.
Directorate:	Children and Young People's Services Directorate
Aims:	To raise awareness of the specific safeguarding responsibilities of the chairperson of Governors and designated governor for child protection and safeguarding in the context of the quality assurance role of a Board of Governors.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • Understand the impact of legislation and government policy in relation to safeguarding and child protection within your school. • Recognise the role of the Schools Safeguarding Team including the specific safeguarding responsibilities of the Chair of Governors and Designated Governor for Child Protection. • Identify the quality assurance role of a Board of Governors in overseeing the safeguarding and welfare of all pupils enrolled in a school.

Course Title:	Developing Shared Education
Target Audience:	The target audience for this training course will be all Governors interested in finding out more about shared education and the benefits that it can bring to their school.
Directorate:	Education Directorate
Aims:	This course provides an opportunity for Governors to explore the impact and benefits of shared education for schools and local communities.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To develop a greater knowledge and appreciation of shared education in practice. • An understanding of the legislative and policy context for shared education. • An exploration of the impact of shared education in regard to educational, economic and social benefits for schools. • To examine the role of Governors in promoting shared education.

Notes:	<p>This course is highly relevant following the publication of <i>'Sharing Works' – a Policy for Shared Education</i> and the passing of the <i>Shared Education Act (May 2016)</i>.</p> <p>Places for this course will be allocated on a 'first come first served' basis and limited to 2 Governors per course.</p> <p>Where a school is in a shared education partnership Governors from partnership schools are encouraged to attend together.</p>

Course Title:	Effective Governance
Target Audience:	All Governors of Nursery, Primary, Post-Primary and Special Schools.
Directorate:	Education Directorate
Aims:	To review the statutory functions of the Governors and will further develop an understanding of how the Board of Governors can contribute to school improvement.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To clarify the statutory roles and responsibilities of Governors. • To promote effective teamwork to ensure effective governance. • To gain an understanding of how to use self-evaluation processes to promote school improvement.

Term/s:	Terms 2 and 3
Notes:	<p>This course will be of particular relevance to:</p> <ul style="list-style-type: none"> • Inexperienced Chairs who wish to promote excellent Governance. • Boards who would like to review how they can contribute to school improvement.

Course Title:	Employee Relations
Target Audience:	The target audience for this training course is all Governors in Nursery, Primary, Post Primary and Special Schools.
Directorate:	Human Resources Directorate
Aims:	To provide a generic overview of Employee Relations procedures in schools including the relevant procedures for both teaching and non-teaching staff in schools.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • Have a better understanding of the following procedures: <ul style="list-style-type: none"> - Disciplinary - Grievance - Bullying and Harassment • Specifically note the relevant procedures for teaching and non-teaching staff. • Understand the processes involved in: <ul style="list-style-type: none"> - Presentation to an Independent Appeals Committee (LRA) - Undertaking an investigation - Producing an investigation report - Conducting a hearing or appeal • Know where and when to seek help. • Generally, 'understand the role of HR'.

Course Title:	Finance Induction Training for School Governors
Target Audience:	New Governors and Governors who have not attended previous school finance training.
Directorate:	Finance and ICT
Aims:	Overview of school finance including the current challenges and framework, the role of the school governor and good financial management, and EA's new approach to financial planning.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • Awareness of the school finance framework and understanding the role of governors in good financial management.
Format/ Duration:	<ul style="list-style-type: none"> • Presentation • Discussion/Feedback • 2 Hours
Term/s	Terms 1, 2 and 3
Notes:	<p>EA are currently transforming School Governor Finance Training to include online video based eLearning. Areas covered will include the framework of school finances, the role of the governor in school finance and effective monitoring of school finances within the current framework. The new online training will enable ongoing access for school governors, permit accessibility anywhere and anytime, and enable governors to consider the materials individually or as part of Board of Governor meetings. Online learning will supplement and support a range of face to face sessions. Schools will be kept up to date on when the new training is available, which is expected to be in February 2019.</p> <p>Places for this course will be allocated on a 'first come first served' basis.</p>

Course Title:	Induction for New Governors
Target Audience:	New Governors and those returning to Boards of Governors after a break in governor service.
Directorate:	Education Directorate
Aims:	This course is an important introduction to the role of a Governor. It outlines essential information on the structure, role and responsibilities of Governors and how Boards of Governors function as a governing body.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To have an appreciation of the educational context in Northern Ireland. • To understand the roles and responsibilities of Governors. • To understand how an effective Board of Governors operates.

Course Title:	Managing Attendance (Repeat)
Target Audience:	<p>Principals, chairpersons of Boards of Governors and designated Governors for staff health, welfare and attendance.</p> <p>This course is a repeat of the course which took place in the 2017-18 academic year.</p>
Directorate:	Human Resources Directorate
Aims:	To maximise staff attendance and manage sickness absence.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To raise understanding of attendance policies and procedures. • To raise understanding of the roles and responsibilities in relation to the management of staff attendance both teaching and non-teaching, with particular focus on recent changes and developments in this area including good practice tools and support available to staff.
Format/ Duration:	<ul style="list-style-type: none"> • Presentation • Discussion • Questions/Answers • 2 Hours duration
Term/s:	Terms 1 and 2
Notes:	<p>Reference will be made to the following policies during the course:</p> <ul style="list-style-type: none"> • <i>Teacher Attendance Procedure (TNC2008/2)</i> • <i>Regional Strategy for the Management and Promotion of Teacher Attendance</i> <p>Places for this course will be allocated on a ‘first come first served’ basis and limited to 2 Governors per course.</p>

Course Title:	Managing Health and Safety in Schools
Target Audience:	Governors with a Health and Safety role within the school.
Directorate:	Operations and Estates Directorate
Aims:	This course is an important introduction to the role of a governor in the management of health and safety within the school. It outlines essential information on the structure, role and responsibilities of Governors and how Boards of Governors function as a governing body within a Health and Safety Management System.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To make participants aware of their health and safety responsibilities as school Governors. • To explain an effective Health and Safety Management System for schools. • Practical application of risk assessment in a school setting.
Format/ Duration:	<ul style="list-style-type: none"> • Presentation • Workshops/Discussion • Questions/Answers • 2 - 2.5 Hours duration
Term/s:	Terms 1, 2 and 3

Course Title:	Managing Redundancies
Target Audience:	<p>The target audience for this training will be chairpersons and those Governors who are members of sub-committees of the Board of Governors required to deal with redundancy situations. Governors in schools where there are likely to be teaching (controlled schools) and/or non-teaching redundancies (controlled and maintained schools) in the current school year are particularly welcome.</p> <p>Please note that if you are managing a teaching redundancy in a controlled school, or non-teaching redundancy in a controlled or maintained school your Board of Governors will receive support directly from the Human Resources directorate on request. Principals as secretaries to the Board of Governors are also welcome.</p>
Directorate:	Human Resources Directorate
Aims:	To provide a generic overview of redundancy processes including; the legal context and duties of employers, redundancy procedures within schools for teaching and non-teaching staff including consultation with staff and trade unions and the relevant meetings, roles and responsibilities within Boards of Governors, criteria for compulsory and voluntary redundancies, and transferred redundancy processes.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To raise awareness of redundancy legislation, policies and procedures. • To provide advice and guidance to Governors in relation to the redundancy procedures. • To ensure that redundancies are made fairly and managed correctly in relation to the redundancy procedures.
Format/ Duration:	<ul style="list-style-type: none"> • Presentation • Questions/Answers • 1.5 - 2 Hours duration
Term/s:	Terms 1, 2 and 3
Notes:	<p>Priority may be given to schools where there are likely to be teaching (controlled schools) and/or non-teaching redundancies (controlled and maintained schools) in the current school year.</p> <p>Places for this course will be allocated on a ‘first come first served’ basis and limited to 2 Governors per course.</p>

Course Title:	Recruitment and Selection Training (Repeat)
Target Audience:	<p>This training provides guidance in recruitment procedures for teaching and non-teaching posts in controlled schools and non-teaching posts (only) in maintained schools.</p> <p>The target audience for this training will be those Governors who have not previously attended training in recruitment and selection, or those who have not attended this training for some time. Principals are also welcome to attend. Attendance is recommended only where essential for recruitment which is planned to take place in the 2018/19 academic year. A review of recruitment processes is on-going, including the development of on-line recruitment. Therefore, it is anticipated that a refreshed 'Recruitment and Selection' module will be launched following this review.</p> <p>Please note that if you are conducting a principal appointment in a controlled school your Board of Governors will receive support directly from an adviser and at least one assessor assigned by EA. This course is a repeat of the course which took place in the 2017-18 academic year.</p>
Directorate:	Human Resources Directorate
Aims:	<p>This course will provide a generic overview of the recruitment and selection processes including; the key documents, the shortlisting process, interviews and decision making including the marking scheme. The course content is underpinned by relevant Equal Opportunities Legislation which applies to all appointments.</p> <p>For the purpose of this training, the EA marking scheme and documentation will be referenced; both of which are requirements for those Governors appointing non-teaching staff to controlled and maintained schools, and teaching staff to controlled schools.</p>
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To raise awareness of equal opportunities legislation, policies and procedures. • To provide advice and support in relation to recruitment and selection of staff. • To raise awareness of the responsibility of Governors in relation to the appointment of staff. • To ensure that appointments are made fairly, with due attention to appropriate legislation. • To raise awareness of the EA marking scheme and agreed documentation.

Course Title:	Recruitment and Selection Training (Continued)

Course Title:	The Special Educational Needs and Disability (SEND) Act (NI) 2016
Target Audience:	The target audience for this training course is all Governors in Nursery, Primary and Post Primary Schools.
Directorate:	Children and Young People’s Services Directorate
Aims:	The SEND Act (NI) 2016, revised SEN regulations and revised Code of Practise are the key building blocks in delivering a new SEN Framework. This course will introduce Governors to the various elements of the new framework being introduced between 2016 and 2018/19.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To raise awareness of current and new legislation and policy in regard to children and young people with SEN including the new duties as outlined in the SEND Act (NI) 2016. • To inform Governors of the proposed new SEN Framework. • To highlight new responsibilities for Governors regarding their statutory duties in relation to children and young people with SEN. • To discuss the timeframe for the full implementation of the SEND Act (NI) 2016. • To inform the quality assurance role of a Board of Governors in overseeing SEN provision, and in implementing the new duties for supporting children and young people with SEN.
Format/ Duration:	<ul style="list-style-type: none"> • Presentation • Case study/Discussion • Questions/Answers • 2.5 Hours duration
Term/s:	Terms 1, 2 and 3
Notes:	Places for this course will be allocated on a ‘first come first served’ basis and limited to 2 Governors per course.

Course Title:	The Role of the Chair of Governors
Target Audience:	Chairpersons, vice-chairpersons of Boards of Governors.
Directorate:	Education Directorate
Aims:	As the work of Governors becomes ever more essential to the effective management of the school, the position of the chairperson is crucial. This session will outline the specific role of the chairperson in relation to the work of the Governors and the strategic management of the school. It will focus on the aspects of the chairperson's role, such as the organisation and chairing of meetings and the relationship with the Principal.
Course Objectives/ Outcomes:	<ul style="list-style-type: none"> • To clarify the specific duties of the chair of the Board of Governors. • To review the skills and attributes required of the chairperson. • To appreciate the importance of the relationship between the principal and the chairperson. • To understand the responsibilities of the chairperson with regard to good Governance.
Format/ Duration:	<ul style="list-style-type: none"> • Presentation • Interactive Workshops • Discussion/Feedback • 2 Hours
Term/s	Term 2
